AEF Scholarships strive to reward outstanding students of AISD with scholarships to make the transition from high school to college as seamless as possible. Rising poverty levels, coupled with continuing escalation of tuition, room/board costs, books, student fees, transportation, etc., can make it difficult for many graduating seniors to continue their education. COOL (College Offers Opportunities for Life) places four full-time college advisors in Abilene ISD schools to assist students who are first in their families to attend college. Advisors assist with college applications, scholarships, applying for financial aid, college tours and college educational presentations from elementary to high school.
